## What Is Your Testimony?

Testimony can be defined as the declaration or presentation of evidence that show something as being true. The Greek word is 'martureo' meaning to be a witness; bear record; be well reported of.

The Hebrew writer wrote in **Hebrews 11:5**, "By faith Enoch was taken away so that he did not see death, 'and was not found, because God had taken him'; for before he was taken he love him and manifest myself to had this testimony, that he pleased God."

> Some time ago I heard someone ask this question, 'If you were put on trial today for being a Christian, would there be enough evidence to convict you?

> My testimony is the life that I live in full view of all men that demonstrate where I stand with God and His standards. While we do not live just to be seen, how we live will be seen. Jesus said in Matthew 5:14-15, "You are the light of the world. A city that is set on a hill cannot be hidden. Nor do they light a lamp and put it under a basket, but on a lampstand, and it gives light to all who are in the house." He went on to say in Vs.16, "Let your light so shine before men, that they may see your good works and glorify your father in heaven."

> Notice Jesus said, "...that they may see your good works..." [Ephesians 2:10].

> Consider with me, two things that serve as testimony of our being in a good relationship with the Lord. The first would be a changed life. Paul wrote in 2Corinthians 5:17, "Therefore, if anyone is in Christ, he is a new creation; old things have passed away; behold, all things have become new." Peter wrote in **1Peter 4:3-**4, "For we have spent enough of our past lifetime in

doing the will of the Gentiles – when we walked in lewdness, lust, drunkenness, revelries, drinking parties, and abominable idolatries. In regard to these, they think it strange that you do not run with them in the same flood of dissipation, speaking evil of you." They will speak evil of you because they see a difference.

Another item of testimony is our love for one another. Jesus said in **John 13:34-35**, "A new commandment I give to you, that you love one another; as I have loved you, that you also love one another. By this all will know that you are My disciples, if you have love for one another." Love is a demonstration of our imitation of God. Paul wrote in **Ephesians 5:1-2**, "Therefore be imitators of God as dear children. And walk in love, as Christ also has loved us and given Himself for us, an offering and a sacrifice to God for a sweet-smelling aroma." Notice **1John 4:11**, "Beloved, if God so loved us we also ought to love one another".

What is the testimony of your life? When people see you, do they see evidence of one walking with God? Let each of us strive to have it said of us that which was said of Enoch, 'He had this testimony, that he pleased God'.
